RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

IN CONSIDERATION of access to and use of the facilities of the member pools and their respective legal owners (Hawks Landing Pool, High Point Pool, Hill Farm Pool, Maple Bluff Country Club, Middleton Swim Club, Monona Swim Club, Nakoma Country Club, Parkcrest Pool, Ridgewood Pool, Seminole Pool, Shorewood Pool, and West Side Pool, collectively referred to as the "Hosts") of the All-City Swim/Dive League, Inc. (the "League") for use in events by the Hosts and the League, THE UNDERSIGNED, in his/her individual capacity as well as parent or guardian of the below listed minor child/children (the "Children"), for himself/herself, his or her personal representatives, heirs, and next of kin:

1. HEREBY WARRANTS AND REPRESENTS that: (i) he or she understands that the particular activities which the Children may undertake at the Facilities may involve vigorous physical exercise, including by way of example swimming, diving, exercise, and prolonged or peak physical activity, as well as use of recreational equipment or other devices located at the Facilities (collectively, the "Activities"); (ii) he or she understands that there are significant risks associated with participation in the Activities, including by way of example the possibility of serious injury or death caused by falling, exertion, physical activity, drowning, accident, injury related to use of equipment or devices, or injury caused by or inflicted by the acts or negligence of other participants; and (iii) the Children are in sufficient physical condition and are physically able to undertake all Activities, and have no disability, impairment or ailment preventing him or her from active or passive exercise, or that will be detrimental to his or her health, safety, comfort or condition if he or she does so engage or participate.

2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the League, its directors, officers, agents and employees (the "Releasees") FROM ALL LIABILITY, TO THE CHILDREN AND THE UNDERSIGNED, their personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE CHILDREN ARISING OUT OF OR RELATED TO THE ACTIVITIES OCCURRING WHILE AT THE FACILITIES, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE (BUT NOT INCLUDING INTENTIONAL OR RECKLESS ACTS OF THE RELEASEES).

HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST the Children or the Undersigned may incur arising out of or related to THE ACTIVITIES WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE (BUT NOT INCLUDING INTENTIONAL OR RECKLESS ACTS OF THE RELEASEES).

HEREBY ACCEPTS THE RISK AND ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE TO THE CHILDREN arising out of or related to THE ACTIVITIES whether caused by the NEGLIGENCE OF RELEASEES or otherwise (BUT NOT INCLUDING INTENTIONAL OR RECKLESS ACTS OF THE RELEASEES), and furthermore acknowledges, pursuant to the recreational activities statute, Wis. Stat. § 895.525, that the Children have a responsibility to act within the limits of his or her ability, to heed all warnings regarding participation in the recreational activity, to maintain control of his or her person and any applicable equipment or devices, and to refrain from acting in any manner that may cause or contribute to death or injury for himself or herself or to other persons.

There will be a PARENT/COACH informational meeting on Sunday night, June 9th at the Blackhawk Country Club (3606 Blackhawk Drive). We ask at least one parent of each family (new & old) to attend (if possible, no children). Parents of swimmers should arrive at 6:00 pm, and parents of divers (not doing swim team) arrive at 6:45 pm. Please bring all of your questions, as our coaches & parent committee representatives will be present to speak with you. There will be a cash bar available!!

Our Swim and Dive **TEAM SUITS** and **TEAM SWEATS** will be ordered through Middleton Sports and Fitness. For any questions regarding the team suits, please call at 836-3931. Team suits and sweats are an optional item, and are available immediately.

ALL PARTICIPANTS WILL RECEIVE A TEAM T-SHIRT. THESE WILL BE AVAILABLE FOR PICK-UP AT ALL EARLY SEASON PRACTICES, FOR THOSE WHO REGISTER BY APRIL 22nd. Those who register after that time will receive their shirts at a later date.

Early Season Practice: (June 3-6 and June 10-13)

- 8&under and 11&12: 5:00 to 6:00 pm
- 9&10 and 13&older: 6:00 to 6:50 pm

Main Season Practice: (Begins June 17th)

- Please attend only the practice time for which you selected on the registration form (either 12:00 pm to 1:15 pm, or 4:45 pm to 6:00 pm). These practices will meet daily, Monday through Thursday.
- There will be Friday practices on July 12, 19, and 26. These will be from 10:30 am to 12:00 pm, and will ONLY be for divers participating in that day's dive meet.
- Special practice on Tuesday, June 25th from 12:00 pm to 1:15 pm, for all divers participating in that evening's meet.
- There will be no evening practice on Tuesday, June 25th.

Team Requirements: ***** NEW IN 2013 *****

- All 10 and under divers must be able to do 4 dives to be on the dive team. Divers may join the team at any time during the season in which they become able to perform the required dives.
- All 11 and older divers must be able to do 5 dives to be on the dive team. Divers may join the team at any time during the season in which they become able to perform the required dives.
- Due to physical and space limitations, dive team members will not be permitted to take diving lessons.

Dive Meets:

- Home: June 28, July 5, and July 12
- Away: June 21, June 25, July 19, and July 26
- All-City: July 29 and 30 (Divers must compete in 3 regular season meets to be eligible)
